I, Brian D. Hill, was an autistic blogger from 2009 to 2012. I was young at the time I started waking up, I woke up to the elite agenda when I was 16 years old. I started up a political organization when I was 19 years old to bring alternative news to the internet, I became a target ever since then by this shadowy government force for whatever the reason or reasons why. I don't know because I don't have access to top level security clearance information concerning myself, my name, and my identity. They can lie about me and I would have no right to have access to it. I was all about

standing up against the corrupt elite agenda by the Deep State Swamp and it's corruption. One of the reasons I was fighting the New World Order was because of my type one brittle diabetes caused by the vaccines given to me as a baby, and because Big Pharma has blocked me and other diabetics from ever having access to any cures for diabetes. I fought against it because the Big Pharma disabled me permanently and then I hear how they want eugenics and want to kill off the useless eaters with this "great culling" they dubbed it, and yet I am disabled because of the very people who call me a useless eater. I didn't choose to be disabled at age one and a half (I was a baby when I became diabetic) where I couldn't work a job, Big Pharma chose it for me to make a profit off of tax paid moneys from my disability health problems. That isn't fair of the elite to cause my disability by Big Pharma and then turn around and say I am a useless eater on government assistance. I am very smart and I refuse to accept being called a useless eater by the elites. I refuse to accept Nazi ideologies of the globalist elite that I need to die because I am not what the elite want me to be. So I had ran USWGO Alternative News and had became a target of the Obama Administration and the CIA/NSA/FBI/DOJ Deep State armada. The proof you can vet and the evidence you need to show that I ran a legitimate organization back then, worked with other patriots and alternative media including political activists against the New World Order agenda. The same agenda Donald Trump had spoken out against on multiple occasions. I praise Donald Trump for talking about the New World Order agenda, exposing it.

I have been damaged by vaccines since I was a kid in the 90s and it wasn't just type one diabetes I got because of my body having an autoimmune attack which attacked my pancreas causing permanent failure and thus I have type one brittle diabetes. It had made me mildly autistic. Autism Spectrum Disorder. The vaccines had also caused me to have violent autistic meltdowns which almost landed me in criminal trouble as a minor decades ago, and the fault was the public school system forcing me against my will as a kid to take the schedule of vaccines and I even had severe sickness and vomiting as a kid, and so it actually weakened my immune system. It took many years and alternative medicine to severely put an end to my autism

meltdowns which were caused by Big Pharma. They wanted to damage me and then throw me and other autistic people in prison or jail or strict probation out of what the vaccines had done to me and other autistic people. Like a double attack and exploit on me and other autistic people. They are exploiting the disabled and throwing autistic people in prisons across the country for simply their behaviors. I had met inmates which have had severe mental limitations, meaning those who have a more severe brain damage and/or autism spectrum disorder just siting every day in prison or jail. Some of the inmates or at least the few I was personally a witness of a long time ago were I believed raped by other inmates, meaning other inmates took advantage of a man's severe mental issues and had sex with that person knowing that he wasn't in the competent mental state to give consent, so it was rape. I am aware of the rape of a few inmates with severe mental disabilities because others take advantage of it. Then I am aware of the physical abuse of pre-trial inmates when we are supposed to be innocent until proven guilty.

It is horrible, and I have seen the abuse of inmates including in the year of 2019 (I believe March or April of 2019) the Warden of FCI-1 Butner, North Carolina, with blond hair, the WARDEN had multiple guards kicking a man in a wheelchair and throwing him out of the wheelchair and continuously kicking him over and over again while a lot of inmates watched. I then sent an electronic message to the Warden on TRU-LINCS system informing the Warden that I used to be alternative media, have a book about me being framed on Amazon books, and told the Warden that I would write a book about her abusing the inmates when I get out of prison. Then she, the blond headed warden retaliated and had me secretly or quietly sent to the holding cell at FCI Petersburg, VA indefinitely without notifying the court where I was transferred to so that the Federal Marshals had no clue where I was after the mental evaluation, where they could have killed me and nobody would know where I had disappeared to. I informed enough guards at Butner of my alliance with a certain political group, the group known as Q, that the other guards allowed me to get commissary at FCI Petersburg to send a letter to the U.S. District Court where I had been secretly or quietly moved to, and then the U.S. Marshals or deputies or contracted officers were called to take me away from that facility where they secretly held me without my lawyer being notified while I was in solitary

confinement, and I think they were planning to have me rot there while they search for me, or have me killed. Luckily because of the white hats in the prison system, I ordered commissary while in solitary confinement, then I was released on bond in May of 2019 shortly afterwards. I have been politically targeted a lot in the last 14 years of my life. Targeted, I had received death threats and rape threats, hacker attacks on my website of uswgo.com, threats to set me up and have me thrown in prison on fabricated evidence. The threats were reported to the FBI and State Police, but nobody does anything about it.

So I am sharing a short documentary (approximately 32-33 minutes) which I feel you need to look at using a standard Blu-Ray player which accepts DVD discs with Blu-Ray quality or the other disc has the video file of the short documentary with all of the facts which you need to know.

I believe personally that I have been a target of the CIA/NSA and the corrupt DOJ/FBI since I ran USWGO Alternative News from 2009-2012. They have threatened me and my family. I filed a FOIA Request in 2017 or 2016 asking the CIA for my case file, anything about myself, and they refused to do such without an executive order from President Trump. I then mailed a written request to President Trump to declassify my CIA file or let me look at it to see if they were lying about me or were involved in interfering with my constitutional rights in my federal criminal case or were directly involved in framing me and manufacturing evidence against me in my criminal case. I was blocked from getting any letter or information to President Trump to take any action. That was why I had intended to ask those who personally knew Trump to convey information (like my federal unsworn Affidavit) to him out of desperation. I had to go through Roger Stone who had agreed to help me but it was only on December, 2020, when he initially agreed to help me as long as I kept it confidential at the time as he warned that it would fail if not kept confidential; I kept my word until he had failed (which he notified me by text message) because the CIA was spying on my text messages and the CIA/NSA were spying on Roger Stone's text messages and had intercepted his attempt to get my Affidavit and letter to President Trump, I was unable to receive a full unconditional pardon. Then the CIA or anonymous Deep State spook or spooks made it known by posting a comment to the justiceforuswgo.wordpress.com blog after Trump

left office that I will never get a presidential pardon and will never be acquitted no matter what I do, by saying certain people don't get pardons with a smiley face to taunt me. So I had been a target of the CIA while they refuse to let me obtain records from FOIA about how the CIA has been targeting me and I believe they had framed me with a crime I never committed to keep me off of the internet forever and take away my Freedom of Press and Freedom of Speech. They stolen my First Amendment right. My First Amendment right to free speech and free press has been stolen by the Deep State operatives of the U.S. Government since I was arrested in December, 2013.

Look, the U.S. Probation Office knows I am innocent, and has witnessed enough junk going on in my federal criminal case, they know I wasn't given a fair deal, they know that discovery materials have been destroyed and covered up by the government, they know I have enough evidence in my federal case indicated that I was set up, I was framed, discovery material evidence was destroyed off the wazoo and documented as to the evidence destruction, and I have suspected that the CIA is involved in what happened to me. They will make sure that I can never prove the CIA targeted me for over a decade, and even if I could prove the CIA targeted me for operating an alternative media political blog, they will use their control of blackmailing the federal judges (as Attorney Lin Wood made it known that judges and officials may be blackmailed with Jeffrey Epstein type *blackmail materials*) or threaten them or bribe them into keeping me convicted or charge me with Obstruction of justice for falsely pleading guilty. I was tortured and my nose broken, my clothes ripped off by the jail guards. The Federal Marshals knew a certain amount of the judicial corruption in my case. It has become a big problem and the CIA is believed to be at the center of all of this. If your able to President again, the CIA needs to be investigated, audited, they need to be sanctioned and all case files need to be reviewed by yourself or people who you can trust and be entirely reviewed by Congress. We need to hold the entire CIA accountable and look through every file (to determine how many crimes were committed by our CIA and not even to protect National Security, framing people with sex crimes does not protect National Security at all, it endangers our National Security and *harms the children by such frame ups*) so that they can stop unconstitutionally targeting me and my family, as well as other people they

I am aware that the corrupt CIA/NSA Deep State killed John F. Kennedy for simply being a real President. They unconstitutionally killed Robert Kennedy and the goons who did the deed had committed a treason against our great country by that assassination for simply JFK being a real President. JFK was wrongfully killed for standing up for what he believed in. Medical lab tests ordered then covered up (deleted from my medical chart) without explanation, nobody who is covering things up ever gets in any trouble, nobody gets in trouble except me the one who is being targeted for years. The CIA or DOJ or Deep State, any of their corrupt flunkies have been covering up so much in my criminal cases, they are trying as hard as they can to end me permanently. I do believe thanks to God and Jesus, I am being protected by the white hats including ones in the U.S. Probation Office but if the white hats ever go away, then I am a dead man or by the time they could be through with me I could wish I were dead. They are ruthless and nasty people from the Feds. There are good people in the Feds too but they are powerless or their hands are tied. So I need somebody who is running for office to investigate the CIA, entirely investigate them, all case files including top secret, everything must be investigated at the CIA and they need to be temporarily shut down while files are being combed through. We need this, I recommend to you that we need to hold them accountable if we ever want to see our National Security strengthened by bringing back credibility and honor in our broken government. We need to hold the bad guys accountable once and for all.

I believe the Deep State has been fighting Donald Trump since even before he won the election in 2016. It has been a CIA coup against Trump. I can file up to 100 lawsuits pro se if I ever had to but if I ever did then none of them would go anywhere. I am stuck as chuck. This is a major damage to our democratic republic. I cannot get anywhere no matter what I do or say, and no matter what evidence I have and present with due diligence.

I have autism, they (the Feds) tortured me, videotaped me while I was ordered to strip naked and the guards giggled while the federal jail guards ordered me to touch my genitals and they held the video camera looking happy and that was in December, 2013. Other federal sanctioned jail guards kicked my nose, told me "I WILL RIP YOUR CLOTHES OFF, I WILL FRY YOU LIKE A TURKEY!!!!" and they left my diabetic blood sugar low where I

risked dying in 2014. That would be another assassination attempt on my life in May of 2014, jail guards and it's corrupt administration refusing to treat low blood sugar which can kill me, but I had some stashed sugar packets, the guards came in and started trying to take my sugar packets, and I physically got violent with the guard while he was trying to take away my only source of saving my life with glucose (for my diabetes) and I tried to jump on top of him to attack him for endangering my life. I was thrown to the ground, they broke my nose after kicking me in the face after I yelled allegations that the jail guards worked for North Carolina State Senator Phil Berger Senior. Of course Phil Berger Junior the former District Attorney was involved with Guantanamo Bay torture and/or detention facility in U.S. territory in Cuba as a former District Attorney. That means likely Phil Berger had a CIA connection and used the CIA to come after me ever since. Then as they (Orange County Jail) ran down the hall carrying me while my nose was bleeding before ripping my clothes off as they promised to had me naked in a windowed cell where other inmates could see my naked body, blood dripping out of my nose with no running water in that cell, yelling that I was Brian D. Hill of USWGO Alternative News and I was set up with a certain kind of material. This incident happened before I took a plea agreement when offered time served by Eric David Placke. I was not allowed to see all of my discovery evidence material until after I had falsely plead guilty. I was tortured into falsely pleading guilty and be stigmatized. Having support from the alternative media taken away from me. I was tortured into falsely pleading guilty, this I can prove to you. I have the medical records of those times, just sitting in some filing cabinet or plastic evidence box. I have plenty of witnesses who can give you federal affidavits or state affidavits. I have the medical records and diabetic logs from the jails medical. Whatever is needed to prove to you what the feds have wrongly done to me for over 10 years without any real reprieve in the legal system. It was over ten years because the Obama Administration had me sued by using Righthaven LLC in 2011, with ties to the Obamas. They tried to shut down my alternative media blog using copyright infringement. That failed, so they framed me with a crime one year later.

I wanted justice, so I had started a new short 33 minute Documentary. It is non-commercial. I am not here selling discs. I am here to seek justice against the Deep State who targeted me and ruined my life. I am mailing

I am mailing you this documentary with the facts, and I have the evidence, I have the federal court filings and they can be accessed on CourtListener or PACER, I have it all. I have so much evidence, I am swimming in it. Who cares about evidence, right??? not the corrupt federal judges. **The corporate media refuses to cover my case**.

#### I had produced the documentary entitled: The DEEP STATE can Frame You - the Documentary

My family gave me the link to give to you as I cannot access links because of the Feds holding me hostage in the corrupt U.S. District Court system. I do not have the outlets to make it viral.

I noticed that the corporate media is not too fond of you Donald Trump and even of RFK Jr. because both of you, despite both of your differences, have told the truth and not just read off a propaganda script. So you understand that the truth does not matter to the corporate media because the fake news media is propaganda outlets just reporting on what the Deep State allows them to report as news.

I have the evidence for my federal case which proves the claims of myself in my documentary. I am dealing with the Deep State and their alleged blackmail of federal judges. The federal judges refuse any investigation into such Jeffrey Epstein blackmail of possibly themselves. I am not mad at him.
