

**LETTER TO VIRGINIA STATE POLICE ON EVIDENCE OF
CARBON MONOXIDE POISONING BELIEVED TO BE CAUSED
BY SOMEBODY FROM THE CHIMNEY SWEEP BUSINESS
WHO DENIED EVER CAUSING THE POISONING, MUST SEND
EVIDENCE TO STATE POLICE ASAP**

To Virginia State Police,

I am asking for an investigation into an incident which I believe may have been caused by a business called The Chimney Sweep where the address is located in 1590 Blue Bend Rd, Rocky Mount, VA 24151. I don't know if it is a crime for somebody to cause carbon monoxide poisoning by installing metal tin on top of chimney flue or flues which exhaust natural gas appliances, and when I tried to complain about that business to the Office of the Attorney General, they responded to the Office of Dispute Resolution through a lawyer named Eric Ferguson where JaCody Cassell denied ever doing a service and denied ever doing an estimate. I don't know what crime may have been committed here, but if you think it may be a crime when there is somebody who caused carbon monoxide poisoning which almost could have killed me and my mother, then I am willing to testify, I am willing to make a statement, I am willing to provide whatever evidence you need for an investigation. I can ask my mother if she is willing to testify.

I would like to file evidence with your office to conduct an investigation into a matter concerning a person who runs a business in Rocky Mount, VA where somebody had caused carbon monoxide poisoning of both me and my mother Roberta Hill, almost would have killed us. I fell in November, 2017, hit my head on the desk and blood came out of the laceration in my head, ambulance was called, and I was mentally abnormal at that time due to the

carbon monoxide that I signed a document where I would go the hospital on my own because I had Obsessive Compulsive Disorder in addition to my autism where I had to wash myself in my hand washing and body washing routines before I head to the hospital while I had the laceration in my head. State Police can ask us for the hospital records we have over that and they can even subpoena Sovah Health Martinsville hospital. When we checked the lab results from the medical records obtained in 2019, there was abnormal levels in the blood. Those issues are usually symptoms or signs which are also shown under patients with carbon monoxide poisoning. Sadly the hospital never checked me for carbon monoxide, but the abnormal levels are in my medical record of that time.

I believe that I was under carbon monoxide gas toxicity between October 5, 2017, and September, 20, 2018 when I walked away from my home at night without fully understanding why I left my home at night without my glucose tablets, without my diabetic insulin, and then I thought there was a guy wearing a hoodie who threatened me to get naked and take photos of myself or my mother would be killed. Then at some point I was arrested for indecent exposure by Martinsville Police Department on September 21, 2018. I then written statements to the federal court from Martinsville City Jail that I may have been drugged, some of my memories have been blacked out, where I thought somebody was watching me in the thicket at an area in my neighbors yard or backyard or something. I written this to the federal court as Document #153 in my federal court case.

It wasn't until 2019, I was told by my family during visitation at FCI-1 Butner, North Carolina during a court ordered mental evaluation, I was told that my mother tried to get the foundation checked out after seeing damage started forming in my Apartment which got even worse after my arrest, but there was damage forming before my arrest, around the fireplace, wall near the fireplace started deteriorating in 2018, and ceiling above the front of the fireplace started deteriorating in 2018. Even my U.S. Probation Officer Jason McMurray expressed concerns about this mysterious damage in my Apartment. Anyways, during visitation in 2019, my family members told me about the carbon monoxide being found. I then started asking my family to look into it as it clicked with me, that carbon monoxide was the reason for

the indecent exposure on September 21, 2018. Prior to my indecent exposure charge and the carbon monoxide which caused it, I never wandered away from home with my clothes on and then at some point I am naked. This was an unusual behavior of mine, and I believe it was the carbon monoxide. The carbon monoxide is gone, and my family bought a carbon monoxide detector to prevent this from happening again.

I hope you can find out if JaCody Cassell is the culprit or if it is somebody else working for his company who started the whole carbon monoxide poisoning. I believe it was them unless some stranger decided to just show up and install metal tin on top of the chimney flues as Pete Compton had witnessed. Still, the \$300 signed check proves chimney work was done, and a month after that I fell and hit my head on the desk with the laceration. The reason I fell was because I just blacked out, I couldn't remember when it happened, I just was in my office and then blood was coming out of the laceration in my head. Again in November, 2017, a month after \$300 was paid to The Chimney Sweep business. The business is called The Chimney Sweep. It's in Franklin County, Virginia.

According to the witness, Pete Compton of ACE Chimney & Wildlife, Pete Compton said that somebody had installed metal tin on top of the chimney flues causing gas appliances to have nowhere for that gas exhaust to go, so the gas started flowing through my Apartment and I think my mother's apartment too.

We have evidence that a JaCody Cassell or somebody with a signature, a Cassell had signed a \$300 check from my mother Roberta Hill to The Chimney Sweep. The check was dated October 5, 2017 after work was done with the chimney. I also have telephone records logs from xFinity/Comcast proving that a phone number belonging to a Cassell and to The Chimney Sweep had contacted my mother in 2017. I have proof that the phone call log had shown that for multiple minutes that phone number had the call between me and my mother.

It proves that JaCody Cassell through his attorney Eric Ferguson had lied or made a false statement to the Office of Dispute Resolution who is of

the Attorney General of Virginia in response to my complaint, I think.


I am attaching to this letter, evidence, which my mother will email you. I am hoping for an investigation because (1) if it is a crime somehow to cause the poisoning of me and my mother with carbon monoxide gas then both me and my mother are the victims; (2) The Martinsville Police Department had erroneously and wrongfully charged me with indecent exposure on September 21, 2018, because the officer misunderstood the situation assumed I was lying or my story didn't add up but I didn't know at the time he questioned me that I was exposed to carbon monoxide gas and the hospital deleted lab tests which were ordered were deleted from the chart. It does have evidence of abnormally high resting blood pulse of over 100 two different times. That is technically a tachycardia. Carbon monoxide also causes tachycardia. I suspect a cover up of a portion of my medical records, meaning I suspect the cover up of ordered lab tests. So I was not medically and psychologically cleared as previously assumed. The officer thought lab work was done and other stuff and that was why he said in the police report or criminal complaint under oath that I was medically and psychologically cleared. The ordered lab tests page, had an entry where it said correction deleted from the chart. Lab results were never given to me, they just vanished. Martinsville Police didn't know that I had something causing intoxication in my body in 2018, and something is just covered up or disappears.

I tried to mail the evidence about the carbon monoxide to Martinsville Police Department in 2019, years before I filed the complaint with I think the Consumer Protection office or some kind of office dealing with filing a complaint in the Office of the Attorney General, regarding The Chimney Sweep. The evidence was never looked at in 2019, and the envelope to police chief was never opened, I know because I was given back the envelope of evidence from Matthew Clark which Martinsville Police Department should have investigated that evidence but they did not in 2019.

I believe The Chimney Sweep had caused the carbon monoxide. JaCody Cassell was caught lying when he denied everything and his attorney Eric Ferguson had said if we have the check then produce it or drop the matter.

After giving his lawyer and the Office of Dispute Resolution evidence of a photocopy of the signed check mailed to us by TRUIST bank, the lawyer refused to respond ever again. They dropped discussing the matter any further after this last piece of evidence. The case was closed in the Office of dispute Resolution.

I suspect a crime of some kind, and maybe it was a plot to kill me and my mother, maybe it was an innocent mistake which was a very costly mistake causing me to fall and hit my head, blood coming out, the gas almost killed me and my mother, the carbon monoxide gas. It caused the behavior of indecent exposure on September 21, 2018. The Police never knew at the time when they charged me, they never knew that carbon monoxide caused me to behave weird, not make sense when being questioned. This is real evidence I have, and if there is a crime somehow as to what terrible things happened to both me and my mother, then I would like to press charges if given the opportunity. I am willing to press charges if any crimes were committed by The Chimney Sweep and/or JaCody Cassell.
