My son is wanting to report evidence of carbon monoxide poisoning attempt in 2017, caused incident in 2018. He is not sure what would be considered a crime here, and maybe your officers can find what crime was committed here.

This is involving JaCody Cassell and The Chimney Sweep in Rocky Mount, Virginia. Evidence of metal tin installed on top of chimney flues at my owned Triplex in Martinsville.

My son wanted me to email you the evidence, and you will have the witnesses if you need to question anybody over this. My son asks for an investigation and if there is evidence of a crime, my son would like to press charges against whoever installed the metal tin on top of my chimney as what he said in his letter. I don't know what I can do, I don't know if anything will even happen. As to me, I kind of wanted him to let this go but he wants me to email this to you because he wants the truth to come out, he wants accountability, and he wants to set the record straight as to his wrongful arrest on September 21, 2018. Brian thinks if JaCody Cassell gets arrested or whoever from his company had poisoned my son with carbon monoxide, that Brian will be acquitted and the wrongs will be righted.

I do hope for justice of some kind. An investigation would find a lot of things out. Uncover crimes that we may not be aware of. Maybe there is already evidence of a crime as to what happened to me and my son who suffered under this carbon monoxide gas. I would be happy for some form of resolution or justice, then my son can finally receive true justice to get his life back.
