Dear Record/Information Dissemination Section of the U.S. FBI,

Pursuant to Title 5 U.S.C. § 552, Freedom of Information Act ("FOIA"), I am filing this request on a Pro Se basis, as a respectful individual in his individual capacity, and requesting a small number of specific records, if such records exist and can be located.

The records I am requesting are of any copies of documents, phone call recordings in any audio format, memos, digital records, transcripts, any voice messages, and/or any other record in a tangible format that is of relevance. The records I am requesting is in reference to any records concerning myself "Brian David Hill" at the Greensboro, North Carolina, Federal Bureau of Investigation ("FBI") office located at 1801 Stanley Road, Suite 302, Greensboro, NC. The dates I am asking for are all such records that are between the dates April 01, 2018, to May 17, 2018.

**FACTS AND ISSUES WHY FOIA REQUEST WAS MADE**

The records I am requesting is in regards to a complaint that I had filed verbally via voicemail message to (336) 855-7770 regarding my complaint against United States Probation Officer ("USPO") Kristy L. Burton for perjury and also stated in my voicemail complaint that Assistant United States Attorney ("AUSA") Anand Prakash Ramaswamy (Middle District of North Carolina) had knowingly allowed his key witness USPO Burton to commit perjury so I had brought up that he was involved in her perjury which I believe to the best of my knowledge was subornation of perjury. That I had to file such complaint because AUSA Ramaswamy had filed a motion for pre-filing injunction and mass-document-sealing-request over my 2255 Habeas corpus petition on the ground of actual innocence and other grounds. I also had tried to explain to the FBI, in the best way that I could despite my Autism, that the Court may try to massively seal all of my public court filings, so I had needed the FBI to investigate the perjury of Kristy Burton to charge her since AUSA Ramaswamy is allowing her to make multiple false statements and wants it completely sealed from public court record without citing what specific records need to be sealed to comply with the redaction requirements. It is virtually a cover up or censorship gag order in my opinion. I believe that wanted to cover up their crimes and misconduct.

Fact #1: I had mailed condensed evidence of public court record excerpts to the Duty

**Agent Jerry (*direct phone number (336) 855-2671*) with the certified mail tracking number 7017-2680-0000-5750-7135 on April 25, 2018 from the U.S. Post Office.**

**Fact #2: On May 2, 2018, FBI Duty Agent Jerry told me via voicemail that “we're gonna have to have you come down here and give a statement”. On May 3, 2018, he left another voicemail canceling the request for me to come down and make a statement.**

**Fact #3: On May 17, 2018, FBI Duty Agent Jerry told me that the case will not continue by telling me that his boss had thought my complaint and/or evidence was meritless. Thus from what I understand, the investigation will likely not continue.**

**I would like to request any and all documentation including any phone conversation recordings or even notes between myself and the U.S. FBI in Greensboro in regards to my complaint that was thrown out of the FBI due to the boss of Duty Agent Jerry with the direct phone number of (336) 855-2671, had worked at the FBI at the time of such complaint, and still works at that same FBI office. Since the investigation has been closed, no statements were ever obtained from me and none of the witnesses since the request to have me come down to the Greensboro FBI office was canceled, even though me and the three other witnesses all knew that Kristy L. Burton had committed perjury by making multiple false statements at the federal Courthouse in Winston-Salem, NC, on June 30, 2015, in front of the Hon. Judge Thomas D. Schroeder.**

**Since the FBI is not opening up an investigation into this matter from what I understand from what I was told over the phone on May 17, 2018, it may not be subject the the FOIA exemptions that are subject to active or even ongoing FBI criminal investigations. Since the complaint was never accepted by the boss at the Greensboro FBI office or wherever, I ask that such records of what happened be mailed to me in paper format or even mailed on a CD-ROM disc with the document files in PDF format if possible as it may be cheaper to store the FOIA requested material onto PDF files on a CD-ROM disc, and CD-ROM discs use less weight than paper depending on the number of records.**

**The records are for the component within the United States Federal Bureau of Investigation, asking that the FOIA request be targeted at records from the regional Greensboro, North Carolina, office of the U.S. FBI.**

**I have a right to know why my complaint was dismissed by the boss, I have a right to know why they believe it was meritless. I have evidence of multiple false statements of USPO Burton, and that is technical perjury, a technical criminal violation of the law. I want to know why the FBI didn't obtain statements from me and three other witnesses before dismissing my complaint as meritless. Statements are very important before deciding that a perjury complaint is meritless. It is uncalled for. I want to know WHY?**

The Fee Category I am filing this request through is as follows:

**Disability and indigent status:** The request is pertinent to investigating the truth. I am indigent and qualify under Social Security to receive SSI Disability income, and that I qualify for a caretaker under Virginia Medicaid. Since I live off of SSI disability, I cannot afford any fees over \$75. So I like to be notified in advance, if I have to pay any fees per this FOIA request.

I like to receive a written response after successfully receiving and processing this FOIA Request. I request a written response from the FOIA Unit upon successful receipt of this letter and attached "Declaration(Statement under Penalty of Perjury): Release Statement."

Declaration authorized by Title 28 U.S.C. § 1746

I declare that I am Brian David Hill, that I am currently a U.S. Citizen, and that I am born on [REDACTED] 1990.

My SS# is [REDACTED].

I am requesting records on myself. I am the person that is seeking the records of myself and even records concerning information provided by myself to the FBI which from what I understand were not made confidential as I was never asked to keep such information confidential. The complaint that I had made to the FBI is of personal interest, as well as for the public interest since it involves a complaint regarding claims of perjury in regards to my former United States Probation Officer Kristy L. Burton, who I knew made multiple false statements on the stand and on the Petition for Warrant or Summons in regards to the Supervised Release Revocation elements of my criminal case in 2015. Since the evidence I had mailed to the FBI Duty Agent Jerry in Greensboro, NC, is of public court records with notes on the papers to show the FBI Duty Agent where the perjury is (false statements) and that I had warned the Court and U.S. Attorney Office by filing pro se pleadings under Declaration that I believe the Probation Officer Burton had already lied about her claims made to the court regarding non-compliance. I made the complaint in good faith based on what I believe to be factually true, and based on what I believe my family had tried to do to show truthfully regarding such false statements under Oath that was made by USPO Burton on June 30, 2015.

I grant myself permission to request records that contain personal and confidential information on myself.

I live off of my SSI disability and I do not work a job. So I live off of a limited fixed income. I am disabled.

I declare under penalty of perjury that the foregoing is true and correct.
