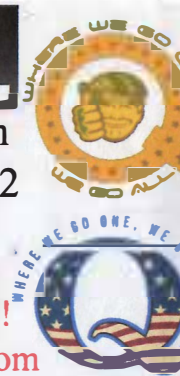

Dear Scott S. Harris, Clerk of the Supreme Court,

I had asked my mother to have OfficeMax/OfficeDepot produce nine (9) booklets for the Justices of the Supreme Court with the tan-colored cover page (*I am doing that out of respect for the Supreme Court even though I understand In Forma Pauperis filings have less stricter formatting requirements than paid case filers*) and it isn't that expensive to have the booklets produced. I know they aren't perfect but I had them do the best that they could.

Anyways, I had the booklets set to be mailed on Friday, October 16, 2020, and it had said in the Petition that it was to be filed on October 16, 2020, to give the Postal Service or UPS enough time to deliver the booklets, for me to package them and ship them to the Court. I had received them earlier than anticipated on October 14, 2020, on a Wednesday. I feel my "Petition for Rehearing" must be filed as soon as possible as President Donald John Trump may be reviewing over my case to determine whether I need a pardon of actual innocence in accordance with Supreme Court case law *Ex Parte Garland*, 71 U.S. 333 (1866). 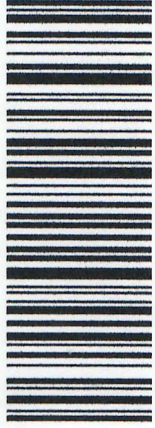

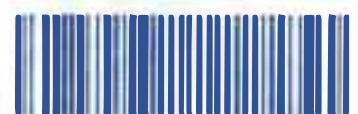
