The Supreme Court has [thrown out the case of Brian D. Hill](#), formerly of USWGO Alternative News along with hundreds of others and didn't even read the petition, just threw it out without opinion and without comment. This is bad because a Federal Court has knowingly held an innocent man hostage to the corrupt judicial thug system with armed US Marshals enforcing illegal and fraudulent judgments. The U.S. District Court in Winston-Salem and Greensboro North Carolina are acting as tribunals that do not comport to controlling case law, authoritative case law. They do not comport to the law or the constitution, they do not comport to their local rules they enforce on the regular average joes.

The entire Middle District of North Carolina federal court system is acting as a gestapo for the Deep State

Brian D. Hill is at risk of being disappeared by the corrupt US Marshals and Chief Judge Thomas David Schroeder. This judge has repeatedly filed fraudulent judgments on the basis of lies and falsehoods. This judge is allowing the U.S. Attorney to get away with not contesting four (4) motions asking for vacating fraudulent begotten judgments. Under Local Civil Rule 7.3, MOTIONS PRACTICE paragraphs (f) and (k), Brian David Hill the criminal defendant was entitled to vacatur of his probation violations and his criminal conviction as a matter of law as Brian had proven that they had no legal basis and/or no factual basis for such judgments so they are based on fraudulent evidence or fraudulent pretenses. The Judge sat on those motions which were pending after they were filed in October, November, last year. Brian filed a Writ of Mandamus asking to compel that the Judge enter an order in regards to those motions. The corrupt Fourth Circuit U.S. Court of Appeals claimed that the Mandamus relief was an excuse to get around the appeal process but that was not true. Brian explained that there is no right to appeal until the Judge makes a decision on a pending motion, that Mandamus relief is meant to be used to compel a Judge to act upon a motion in a timely manner. The Mandamus relief was denied. Brian filed a petition for rehearing explaining that he had every right to request Mandamus relief in accordance with Virginia Supreme Court and U.S. Supreme Court case law precedent that Mandamus may be used to compel a Judge to follow his/her duties of office including making a decision on motions and resolving cases instead of ignoring them. That failed and the U.S. Supreme Court denied writ of certiorari. **So they have given a blank check to hold an innocent man hostage in violation of Writ of Habeas Corpus. They are refusing to let him prove his actual innocence and dismissed his 2255 without giving him any chance to demonstrate that he had already proven his actual innocence but they will not recognize it,** they will not let him see his discovery evidence, they have destroyed evidence material and the Judge knows they destroyed forensic evidence and got away with Obstruction of Justice in violation of 18 U.S.C. § 1503.

They are illegally holding a innocent man under a sentence that is fraudulent, a fraudulent case. Fraud upon the court is actual innocence when the fraud was perpetuated by the federal prosecutor. **This man is being permanently held hostage to a corrupt Federal Judge that scoffs at anything in his defense, ignores all evidence, ignores case law, ignores witnesses but is praising those caught lying under oath, refuses to step aside and refuses to assign the case to another Judge, and is causing him to mention suicide years ago in court documents.** This judge is a bully and bullying an innocent man with Autism Spectrum Disorder and OCD. They are trying to bully him until he gives up on life. This is legal terrorism and they are engaging in criminal and unethical behaviors. The Judge is refusing to recuse himself even though he had filed a unsigned premeditated order of imprisonment months prior to filing a signed order with the same text as the premeditated order, this Judge is OUT TO GET BRIAN DAVID HILL and his FAMILY. The Judge and Prosecutor is out to get him, enough to lie about him publicly, slander him and attacking him, sending armed Marshals after him and calling him a danger to society and ignore his Autism.
