Corporation and Country are different.

WHEREAS I do recognize that you are the **LAWFUL** President of these United States of America. Federal Judges that act under the Corporation of the UNITED STATES OF AMERICA and refuse to follow and protect the Constitution are null and void. They should be of no valid legal consequence. They are illegitimate.
