Hey Clerk or officer of the Judicial Council for the Fourth Circuit,

I am Roberta Hill, Brian's mother. I am filing this Petition for Review for wrongful dismissal of his Judicial Complaint on two judges named in the COMPLAINT on Brian's behalf due to his federal probation conditions where he is not allowed to use the internet. He is having me file this Petition for Review on his behalf.

Clerk Patricia S. Conner should also review over this too and find out why the Judiciary has become so corrupt because of the Deep State and their criminal influence over Government, and why my son keeps losing no matter what case law he uses. Judges are being blackmailed or bribed or threatened presumably by the Deep State, Shadow Government. Why are so many judges working together in attacking my son and lying about him all the time, wrecking all of his appeals, and ignoring the laws or disregarding the laws. None of this makes any sense here.
