To Clerk of the Court,

I am Brian D. Hill, the former news reporter of USWGO Alternative News. I have very important information and a very important request for you. As a Clerk, it is your duty to at least hear me out as a litigant.

In the matter of public interest, I beg of you to publish all filings publicly on the Supreme Court website, including the ENTIRE APPENDIX of the EMERGENCY APPLICATION, yes every page of the entire appendix publicly on the website, because it is very important. Attorney L. Lin Wood as well as other third-parties are interested in watching this new case.

It is very important because I personally believe the federal judges in the Fourth Circuit and the U.S. District Court are being blackmailed with child rape and murder. See the links of articles obtained by my family for me to paste over the issues of federal judges including possibly John Roberts being allegedly blackmailed as described by Attorney L. Lin Wood who has still not been disbarred over those claims last year in January.

Attorney Lin Wood never objected to any of my filings bringing up his name with his claims by showing archived printouts or screenshots of his Tweets but only objected to past claims I made where I assumed he had direct possession of the alleged blackmail videos, but it was his source or sources who had those alleged video recordings. Only text messaged me one time to correct me on the assumption. Other than that, he was notified in every step of the legal proceedings where I had mentioned about Lin Wood's claims as a licensed attorney who made claims which I had taken very seriously because I had suspected for years the judges were bribed or threatened or blackmailed. I suspected a few at the Supreme court level for various reasons, as to why I keep losing in Court so many times no matter what.

Anyways, when you review over the EMERGENCY APPLICATION, you will understand why every page of the appendix must be published on the Supreme Court docket website page. My family had already planned to upload to the Justice Blog the local copies of my pleadings being mailed to your Supreme Court. So the American people would want to know if Lin Wood was right or wrong. He would not be making such claims at risk of disbarment and defamation lawsuits from Chief Justice John Roberts and others named by this attorney, if he didn't have some way of vetting this information to confirm it's legitimacy and credibility.

I am sending you all of this information CLERKS, because you must understand why publish on the website docket every page of my public filings in both my Petition for Writ of Certiorari and Emergency Application, why every page including my letter to Attorney Lin Wood as part of the

Understand my position here. **I am tired of being held hostage by the corrupt criminal actors of the U.S. District Court. The corruption must be held accountable even in our corrupt Federal Courts. This corruption has harmed me and my entire family. It has me held hostage to federal criminals trying to ruin my life forever, give me a criminal record forever, and never allow me to prove my innocence forever.

Clerk, I don't know why you never filed my EMERGENCY MOTIONS in cases no. 21-6036, 21-6037, and 21-6038. I suspected that John Roberts

had a hand in those cover ups of pleadings. Please do not let it happen again, please do not cover up anything I file in the future according to 18 U.S. Code § 2071. That is another reason why John Roberts must recuse himself, to prevent him from influencing the Clerks to cover up filings or cover up mailing boxes with pleadings to make them disappear as if they don't exist.

So you have many compelling reasons to file every filed pleading publicly on your docket website (PDF). The Application has all it needs to know. However I am asking you morally under God to do the right thing this time. The cover ups sabotaged my petitions under cases no. 21-6036, 21-6037, and 21-6038. I cannot sit here and let it happen again.

Blackmail is wrong and if John Roberts truly was being blackmailed, that is wrong and he needs to step aside and not block me from being acquitted anymore. He has no right to block me from proving my innocence or being acquitted on anything if the Deep State is blackmailing him. It is morally wrong and this damage had hurt me and ruined my life.

I do ask you Clerk to do the right thing this time. Please file everything and please file everything on the public docket of the website, so that me and my family can know and understand that nothing is being covered up this time. **The time for criminal conspiracies needs to be over**, the time for persecution against Christians needs to be over.
