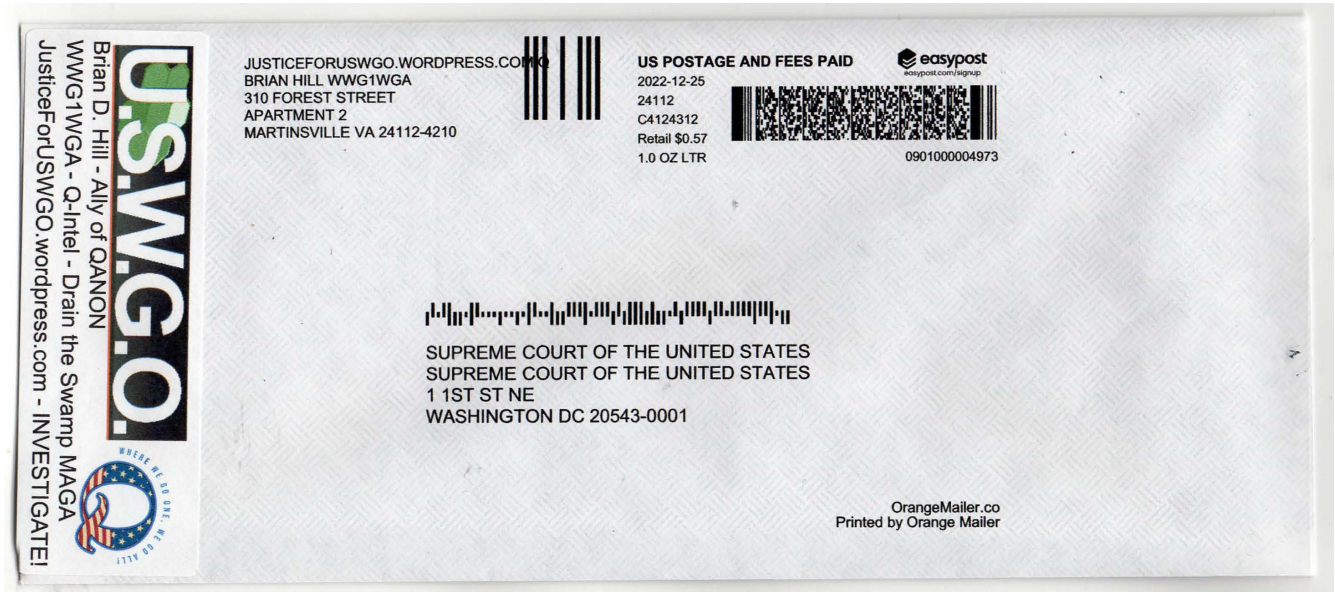


# STATEMENT OF MAILING

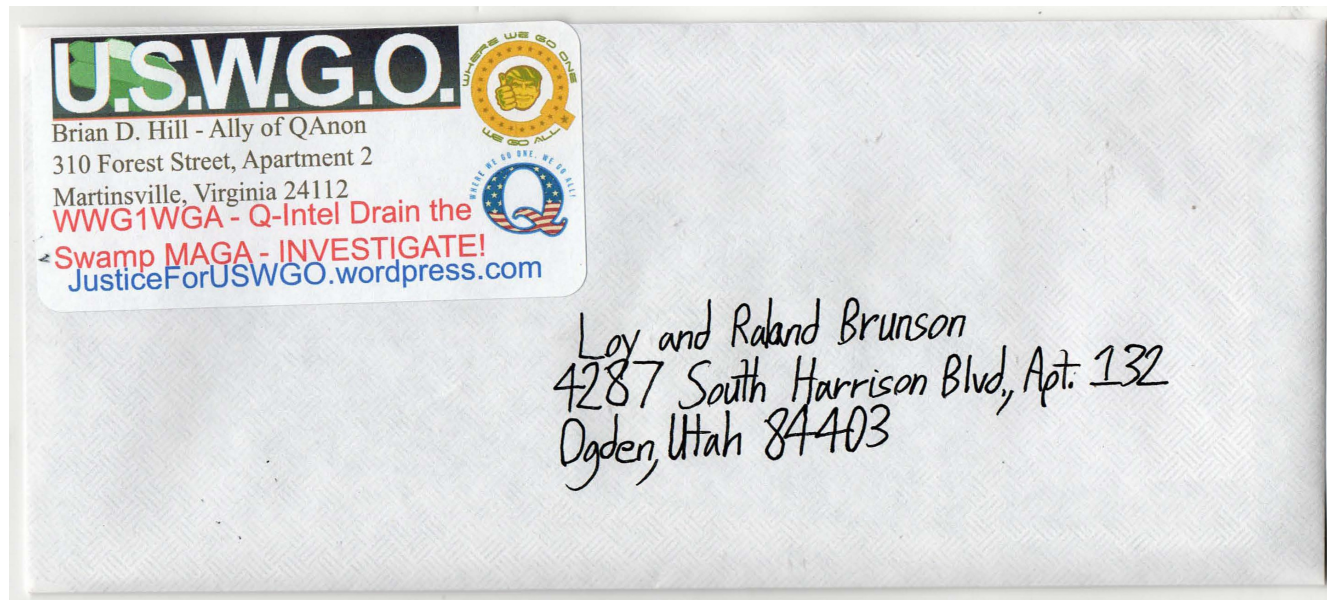

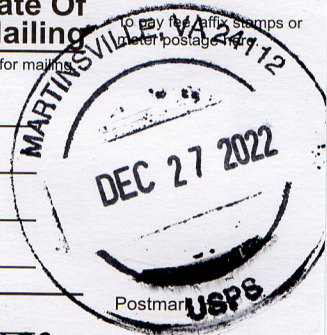

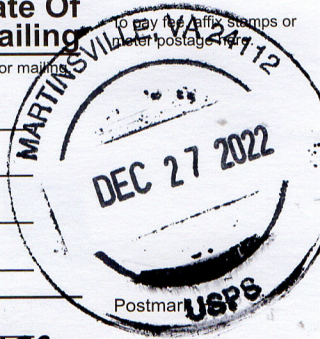
