Mr. Placke,

Attached is a word document letting you know more about Brian.

We received a call from the Guilford County Autism Society on Monday, Dec 30, 2013 and spoke with Judy Smithmeyer. She said she would be unable to be of any help for Brian, but suggested that Brian would be better off in a Medical facility in Virginia until this all gets cleared out because he has a Medicaid waiver for the state of VA, and NC would be unable to do anything for him since he is not a resident of the state. She advised me

that the waiting list in NC for a Medicaid waiver is over 700 in all counties. I explained some of his medical and mental problems, and she said he needs to be evaluated for his Autism, OCD, and the other problems he has and to insure his diabetes is under control.

Brian is more visual than verbal, case in point, recently Brian used a kettle corn popper, and we told him when he uses it do not put sugar in with the popcorn. He acted as if he understood, and we told him several times. After using the popper, he came back into our apartment and said the popcorn had burned and he had problems cleaning it up. He read the instructions and did exactly as it said, even though we told him not to. Someone explained Autism to us as listening to a radio station that keeps cutting out.

Brian's mom, Roberta Hill, told us if the charges are dismissed, she wants him to return to her home, but cannot take care of him under the Adam Walsh Sexual Offender conditions. We know he is not guilty, and believe he was set up because of his political activism. We were working with Piedmont Community Services to get the help he needs when he was taken from the hospital and arrested.
