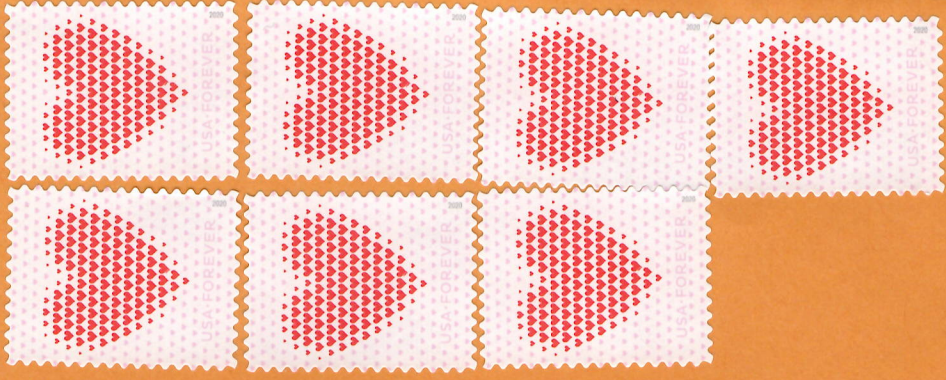

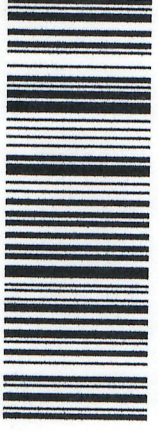

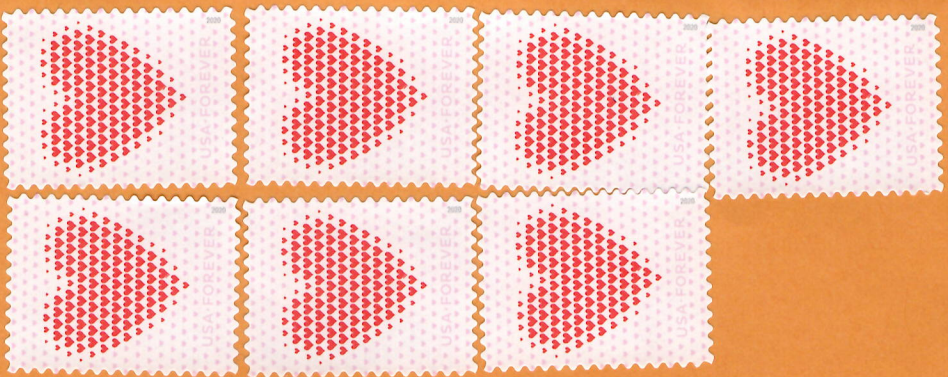

I am Brian David Hill, formerly of USWGO Alternative News and I am an ally of QAnon because I am a serious supporter of Draining the Swamp that U.S. President Donald John Trump had promised us during his first election campaign. JusticeForUSWGO.wordpress.com (or .NL). I am also mailing to you an Audio CD Disc of a 10-minute audio which can be played on any standard Audio CD Player. I am also mailing to you Judge Urbanski's corrupt order and the Fourth Circuit's next parlor trick of making my next appeal dismissed, making their problems disappear, these corrupt Judges protect their own corruption and fraud. You both will receive my letter. I am explaining why the Secretary of Defense should charge the corrupt Federal Judges with high treason and Constitutionally try them all in a Military Tribunal.
