Brian had dealt with his grandad in the hospital who was more recently at a nursing home then had been moved to an assisted living care facility. Brian had gone through the emotions and had decided to write a sentencing letter for the defendant Jonathan Own Shroyer before it is too late. **It is attached to this email in PDF format.**

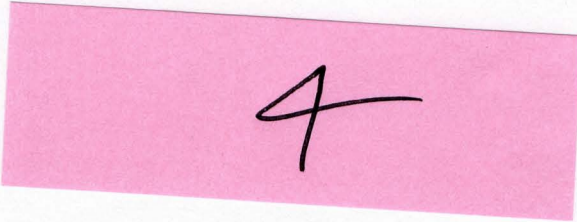

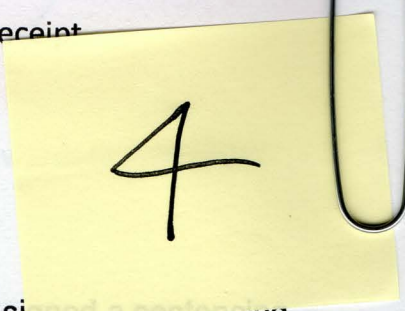

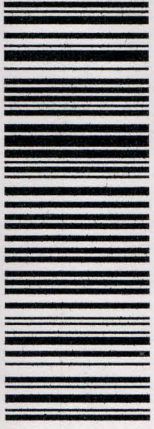
