Attorney General. I have evidence that Fred D. Smith, court appointed attorney, who had been appointed as my court appointed lawyer, had engaged in unethical misconduct and lied to the Assistant Attorney General. This attorney had engaged in manipulation, interfered with my ongoing pro se appeals under CAV cases no. 0313-23-3, 0314-23-3 and 0317-23-3. Attorney Fred Smith refused to present a First Amendment challenge to my contempt of court charge even though I did not threaten the judge, I did not defame the judge, I told the truth about the judge, judge didn't like it, charged me with contempt. Regardless, Attorney Fred Smith knew that his client's appeals were important to him and his constitutional right under procedural due process of law, and the attorney prohibited his own client from access to his own appeals for six months while lying to the Attorney General office that his client was not prohibited from access to his appeals. This court appointed attorney lied to the Virginia Attorney General.
