# EMERGENCY LETTER TO JUSTIN HILL OF OFFICE OF THE ATTORNEY GENERAL; INFORMING THE ATTORNEY GENERAL AS TO THE TRUTH; AS TO BEING DECEIVED BY FRED SMITH

Justin Bryon Hill,

I, Appellant Brian David Hill, need you to know the truth, as that is what is the right thing to do. I understand that you represent Appellees and not myself, but I also understand that you have been manipulated and I have been manipulated in the Court of Appeals of Virginia cases, and that the manipulation came from Attorney Fred Smith who had represented me in my contempt of court case.

You have been manipulated, and I learned this from all of the cumulative evidence I've got. I was manipulated as well.

Attorney Fred Smith said that I needed to call you to get an extension of time and that you or your boss, the Attorney General, had agreed to extend my appeals in presumably cases no. Case nos. 1424-22, 1425-22, 0313-23-3, 0314-23-3, 0317-23-3, 0289-22-3, 0290-22-3. On June 22, 2023, Fred Smith told my mother to tell me that you agreed to have my appeals extended as long as I call you. Instead I had Roberta Hill send you a letter entitled: 2ND EMERGENCY LETTER TO JUSTIN HILL OF OFFICE OF THE ATTORNEY GENERAL - RE: Case nos. 1424-22, 1425-22, 0313-23-3, 0314-23-3, 0317-23-3, 0289-22-3; Wednesday, June 28, 2023.

Then you gave a response back to my mother via email that: "In it, your son

appears to request that I submit a motion for a continuance on his behalf to the Court of Appeals. I would ask that you please pass along to him the same response I gave last time: I am prohibited from taking any legal action on his behalf. Your son, or an attorney representing him, are the only persons allowed to file a motion or request on his behalf. I remain amenable to a motion requesting a continuance, were he to file one. But, I cannot request a continuance or take any other action on your son's behalf."

You knew my hands were tied though. So you told me a completely different story than what my Attorney Fred Smith told me. He said you would go ahead and extend the time for my appeals once I called you. So my lawyer deceived me and had me contact you, and he deceived you too. I don't think you will like that, to know that you were also deceived by Attorney Fred Smith who was appointed by HE WHO SHALL NOT BE NAMED because I may face another contempt of court charge for telling the truth if I point out who the corrupt judge was who messed up my appeals before the Court of Appeals of Virginia to protect certain corrupt people in offices.

Here is what Attorney Fred Smith told me as to why I asked you again for an extension for my appeals. I sent the second request to you because Attorney Fred Smith had my mother to talk with me and had caused me to send a request to you for something upon the false assumption that you would file an extension of time because I could ask you to do so according to Fred Smith and you had already agreed to it after talking with Attorney Fred Smith, according to him.

[Fred Smith]: And, uh, the, the, the attorney general, the assistant attorney (**JUSTIN HILL?**) General that spoke to me expressed concern that Brian has about filing anything until we get this October hearing behind us. [Roberta Hill]: Uh huh. [Fred Smith]: Um, uh, the attorney general will agree to give Brian until after October (**You agreed Justin Hill to give me an extension** 

fo time last year but did not???)

[Roberta Hill]: Ok

[Fred Smith]: uh, of his hearing date, uh, in order to make further filings in the matters he has in the court of appeals. So, Brian needs to call the, the, the gentleman that he spoke with (**JUSTIN HILL?**) and tell him he would like to agree to do that, that he would like that extra time to make filings until sometime on a date after his October hearing date. [Roberta Hill]: Ok, I'll let him know about that. [Fred Smith]: Ok, thank you, Miss Hill.

But then you told my mother Roberta Hill in response to my 2nd emergency letter that you will not give me an extension of time for my appeals. I have a PDF copy of that email you sent back dated Date: 6/28/2023, 9:34 AM, Re: 2nd Emergency Letter to Justin Hill, Attorney General.

So Fred lied to me and caused me to write a letter to you on the word of Attorney Fred Smith who told my mother to tell me that you agreed to already give me an extension of time to file in my appeals. Then you told my mother the opposite of what Attorney Fred Smith told me. So, I thought you were being mean and nasty to me. I was wondering why you were being mean to me in that response messing up my appeals as untimely filed. Now I know the truth, that FRED SMITH LIED TO MY MOTHER, and had me believing that all I had to do was contact you and you agreed to already extend my appeals last year. So maybe you weren't being mean and deceptive to me. Fred Smith told you a different story.

Then you made statements in your brief of the Commonwealth which I felt was a false statement and untruthful, because Attorney Fred Smith did speak to you, and he admitted he spoke with you when I mentioned your name, Justin Hill. In the recorded conversation.

FROM APPELLEES BRIEF: "The contempt charges were dismissed on joint motion of the Commonwealth and Hill on October 23, 2023. Upon information and belief, Hill agreed during the pendency of those contempt charges not to file any new motions in the Circuit Court. That agreement did not prohibit his from filing anything in this Court. (footnote 4) Footnote 4: Undersigned counsel confirmed this fact with

*Hill's appointed counsel in his contempt case during the pendency of those proceedings*." Hill's appointed counsel mentioned was referring to Attorney Fred Smith.

That was a proven lie based on five separate conversation recordings with Attorney Fred Smith and were legally recorded under one party consent. My appointed counsel Fred Smith had ordered and instructed me not to file in ([sic.] any) the "state court" and did not give an exception to the Court of Appeals of Virginia during the sixmonth no filing period.

He even made it clear that I couldn't file in the Court of Appeals of Virginia until after the October hearing date according to the recording of Roberta Hill my mother and Attorney Fred Smith, and other recordings. I have a letter I sent to Attorney Fred Smith last year, and it all goes hand-in-hand with the recordings.

Please confirm RECEIPT of everything. So, please Justin Hill, confirm in writing that you have downloaded the audio recordings evidence from all EXHIBITS in my Motion for Delayed Appeals. Because it is your duty as a Respondent to confirm that you received everything (satisfying my duty to properly serve the Respondent) and that you received all evidence which could only be filed by my family online uploading onto an internet web server and to be downloaded. The evidence pieces are EXTREMELY IMPORTANT.

There are also transcriptions of those recordings and an affidavit about how the recordings were legally recorded under one party consent.

Evidence shows or gives reasonable inference to: Attorney Fred Smith, appointed to my contempt of court charge case no. CR19000009-01, had appeared to have manipulated both sides of the Court of Appeals of Virginia cases by using the contempt of court case as leverage to thwart and shut down my appeals.

I were deceived, you were deceived. As Appellant in the appeals, you should be angry to know that my own court appointed lawyer lied to me and because of that I thought you were a liar and wanted to lie about me. I thought you were being nasty to me last year when you said you were not going to file an extension in your email to Roberta Hill, and I was very angry at you last year after you sent that email response, because Attorney Fred Smith said I should contact you to get the extension and that you had already agreed to have it extended just by telling you that I wanted the extension. I thought you were just a mean liar and wanted to lie about me. Maybe you still do, maybe I was naive. Maybe I misunderstood you and your intent as counsel for Appellees.

I have to now think, maybe I misjudged you, maybe I thought wrong about you as the evidence is showing things which paints a entirely different picture for both parties in my appeals. A picture of manipulation by an attorney who was supposed to represent me.

Attorney Fred Smith had deceived the both of us and that caused my appeals to be dismissed as untimely filed and failure to prosecute my appeals timely.

<u>I would like to ask if you would oppose my motion for delayed appeals or if</u> <u>maybe you would like to respond by revealing what Attorney Fred Smith told you</u> and what dates he had deceived you into making me think you were mean, nasty, and want to just lie about me. Attorney Fred Smith deceived me and he deceived

### you. I now have to ask what you think of all of this. You were deceived too, we are both victims of this. It is time to clear the air. We can agree to disagree. Both of us were fooled by this rotten attorney from Martinsville.

Fred is the reason my appeals failed, I am truthful about that. I was manipulated. You were likely given false information or erroneous information or both.

I plan on suing Attorney Fred Smith for malpractice if I can manage to find any attorney willing to do this on a pro bono basis. I have always been honest with you, because it is ethical and moral even though I am not an attorney. I wanted to fight fair with you like symbolically knights with chivalry; and being fair and honest in the judicial system.

However, Fred Smith caused problems in those appeals. You know the truth, you were lied to. As to how much he has lied to you, I do not know, but only you know what was a lie and what was true.

I know you won't admit to this Justin because you don't want to lose your job, but it is clear that there is judicial corruption in the City of Martinsville, prosecutor corruption and judicial corrupt in Martinsville, and this corruption is starting to be proven with evidence. Brian Clark was another victim of the judicial corruption of the very same people who are in the Circuit Court for the City of Martinsville. Brian Clark had to file a lawsuit and won for harassment by law enforcement after he angered the corrupt judge and it will stems from one corrupt judge, HE WHO SHALL NOT BE NAMED because I don't want to face a second contempt of court charge. So you know which judge I may or may not be referring to, a corrupt judge somewhere in Virginia who I will not name in this letter.
