I don't usually want to inquire on a closed criminal case involving myself as a criminal defendant but right now I have no choice.

I am writing this quick emergency letter to you. This is regard to criminal case no. CR19000009-01.

I am not trying to file anything but rather I am requesting pdf copies of several filings in my contempt of court criminal case for the following emergency reasons and special reasons:

- 1. My appeals in the Court of Appeals of Virginia, cases no. 0313-23-3, 0314-23-3 and 0317-23-3 were all wrongfully dismissed today, because my court appointed attorney Fred Smith in my contempt of court case had lied to me about being granted an extension of time to file my appeal briefs. The contempt of court case had caused me to make an agreement not to file anything in the "state courts" for six months which I had complied with in good faith. I have evidence of these lies and the evidence was already filed with the Court of Appeals of Virginia with due diligence.

- 5. I was never given a copy of the agreement for what led to the joint motion being filed by both the Commonwealth's Attorney and Attorney Fred Smith for dismissal.

So I am asking for filings I was never given any copies of by Attorney Fred Smith who was appointed to my contempt of court criminal case, no. CR19000009-01. I was going to let it go and never try to seek a record from a case which was dismissed, but my appeals have also been dismissed and my constitutional rights to my appeals were taken away because Attorney Fred Smith lied to me the entire time. Please work with me Honorable Jeanie Nunn. As a criminal defendant, I am entitled to copies of my filings and copies of filings my court appointed attorney Fred Smith had filed with your court now that I have caught him lying and the lies going as far as the Court of Appeals of Virginia in the Attorney General's corrupt bid to throw out my appeals and dismiss them as untimely. I will not let this go, BECAUSE I AM INNOCENT OF INDECENT EXPOSURE. UNDERSTAND!!! I AM INNOCENT.

I am appalled that Fred Smith lied to me, and Justin Hill lied to the Court of Appeals of Virginia.
