I, Brian David Hill, would like to report additional evidence and information to your office, William Efird. It is all regarding Attorney Fred Dempsey Smith in my filed complaint against him for misrepresentations, lying to the Assistant Attorney General, and for depriving me of my constitutional right to appeal under the color of law which is a federal crime in itself. Has everyone received the source metadata of the threat email??

Brian wants to make sure that law enforcement has this metadata so that they can trace it to the ISP. Brian wants the person who sent this threat email caught and arrested.

It says they have the judges somehow? Claims they have Martinsville? Is it blackmail? Is somebody being blackmailed here?

It is odd that Lin Wood was in this email too. Brian filed a case before the U.S. Supreme Court in November, 2022 (case no. 22-6123) with the statements from Attorney Wood about the chief justice John Roberts being blackmailed in sex tapes by Jeffrey Epstein or whoever blackmailers had blackmailed the chief justice.

Then there was Evan Neumann in Belarus on asylum who has information that John Roberts visited 300+ child porn websites. My son did an affidavit about seeing a video of Pete Santilli talking about Brian's petition and about this Evan person. My son's claims before the Supreme Court being corroborated by Evan Neumann according to talk show host Pete Santilli and The Big Mig. If Jeffrey Epstein clients or anybody associated with that mad man is involved here, then Brian could really be in danger. Hi Sue,

Hope you had a nice Valentine's Day. We just got home today from a trip. Brian got some of his old computers back from the Mayodan, NC police department. His new attorney brought them to our house for him 3 days ago. They only sent the computers that did not work (We gave Brian our old laptops, and he kept their old ones so he could use parts from them). There was mold on the old computers. Brian did get one laptop hard drive back that he thought was his and would work. It was located at the bottom of everything. We went to Best Buy to get him an external hard drive enclosure and brought it home for him today. He did get to look at it, and this was the first time he has ever seen what child porn looks like. This was not his hard drive, but it had some of his Righthaven information in it. He told us about it, so we destroyed this hard drive so no one else would see such nasty pictures. Brian was shocked and grossed out about what he saw and took the hard drive off of his computer right away and ran up in shock and told us about it, really upset. We also decided to take the old laptops and throw them all away. Then about 2 hours after we came home, Brian got a text message on my phone that he borrows sometimes. Sounds like they are threatening Brian, you and Brian's 2nd attorney, Scott (who asked the judge if Brian could get his computers back that didn't have any child porn on them). The judge ordered in Nov. 2014 that these are to be returned to Brian. They must have had a bug on these computers because we threw all of them away, then went out to eat at a restaurant and were only home a couple of hours when Brian got this email. We really need to contact the FBI for sure. It looks like it all comes from the Mayodan, NC police department. Their town attorney is Phil Berger Sr. who is the NC senator who is 3rd in line to be governor.

Sue, we were only on the Internet for a couple of hours this week, so tonight is the first time that we saw your attachments, threatening emails. It looks like the one Brian got on my telephone as a text looks very similar. The ones he got in 2013 looked similar too. Did the emails that the others got look similar? These are very dangerous people. The FBI had better take this more serious this time. This is a weekend. It's late here, and Ken and I are tired from traveling today. Can you contact the FBI on Sunday or do we have to wait until Monday to contact them?

Thank you for sending us the ones they sent to you. Brian's threat is below. Can you read it ok? It was a text message on my phone, and Brian forwarded it to our email so Ken could print a copy for Brian's records.
