

February 14, 2024 incident notes.

Me, grandma Stella Forinash, grandpa Kenneth Forinash, and mother Roberta Hill finished eating at restaurant Trading Post in Emerald Isle, NC. We were in the KIA of grandpa and grandma. Brown KIA, silver KIA on the paper. The estimated time was around 6PM. It was dark when we left the restaurant. Grandpa drove into Coast Guard road, was behind several vehicles at a stoplight. Then the light turned green, the cars were going ahead, grandpa went forward and then the left turn light was flashing yellow as he was turning then turned red pretty quickly. After that a police car started following us with flash blue and white lights. I was surprised and grandpa made a sound as if he was surprised that a cop car was behind him to pull us over. He pulled over, and I was surprised and scared. I am doing nothing illegal but I have been set up by crooked police officers in the town of Mayodan. However, I was afraid that I was being targeted or my grandpa was being targeted, and my fears were well founded based on evidence and things I have witnessed in my past.

A woman police officer walked up there and she said you ran through a red light when it turned red on the dial. Grandpa I think did tell her that it was yellow when he turned. She asked for license, never asked for registration in his glove compartment. I was in the front passenger seat with grandpa in the drivers seat. Grandma was in the back seat on the drivers seat side, my mother was in the back seat behind me. She walked back to her police car vehicle with grandpa's ID, and I know she never asked for registration. It took a while. I was telling my family members Roberta, Stella, and Kenneth about how corrupt Governor Roy Cooper was for me being set up, grandma told me to be quiet on that. I then said I will be reporting this to Q (referring to Q, the military intelligence group). I also told my mother to tell the officer that I have autism. The officer came back and told grandpa that she was going to give him a warning ticket. A copy for him and she keeps the original on the records. That would be Emerald Isle Police Department according to me witnessing the ticket warning document. It was interesting that she never asked for either registration or rental agreement. She also said about having a happy valentine's day before walking back to her police car. My grandpa normally wears a U.S. Military Veteran hat for being a Vietnam Veteran. So the officer would have known that he was a military vet and that he was elderly at the time she spoke with him.

I felt weird about the whole thing. I have been on many vacations with my grandma, grandpa, and mother and we have never been pulled over by a police officer. We have been in U.S. Military bases because of my grandpa retiring from the military, and I normally would expect them to search our cars or have officers pull us over since military bases are a more secure place. Yet we never got pulled over by a police officer at a military base as long as I have known grandpa in my travels with him and my other family members. I was afraid that this was a set up of some kind because I kind of felt like the officer was pulling something when she said the light just turned red and that he ran a red light.

He left when it was yellow with multiple vehicles in front of him. The officer knew all of that but she stopped us anyways. There was a vehicle that ran on the wrong side of the road and the officer didn't do anything about it. I knew this may have a fishing expedition of some kind, I don't know exactly what, but I suspect that it was a fishing expedition for information. I was afraid that night, and it was hard to get a lot of sleep. I was scared that I was being targeted and that the Emerald Isle Police Department was being used in this. The stoplight was on the same road which led right up to the resort/condo that me, grandma, grandpa, and my mother were staying at from Wednesday, February 14, 2024 through Friday, February 16, 2024.

My mother showed me the email where she informed my probation officer who I would be staying with at the resort/condo which was Kenneth Forinash, Stella Forinash, and herself Roberta Hill. We all have a suspicion that the police officer may have turned the light red on purpose. I have personally witnessed in the past where a completely green stoplight turns red when emergency vehicles start running through a stoplight, the lights turn red during the passing of these emergency vehicles. So I am aware that both police, firefighters, and ambulances can manipulate a stoplight somehow to turn into red lights from a green light in emergency situations. I suspect that the officer turned the light red to pull us over from the start. I had a feeling of fear. I knew this was not a normal situation. I feared that she, the police officer was trying to target me and that this was some kind of intelligence operation aka a fishing expedition.
